- Must be primary residence (proof required)
- Undertake **at least one renovation** that:
 - o is eligible AND
 - Recommended in the report of the energy advisor
- Eligible work must have been made after December 1st, 2020

GENERAL CRITERIA

- All products used must be purchased in Canada (or online from a distributor located in Canada)
- Mandatory to provide detailed invoices for each improvement made. (Labour, products, etc.) Including airtightness work.
- Grants awarded cannot exceed the total cost invested for each individual measure listed on the invoice.
- House Extension: Not eligible for subsidies.

- Les subventions sont complémentaires au programme Rénoclimat et ne peuvent s'additionner. Le montant le plus avantageux sera pris en compte
- Keep invoices and documents related to the program **until March 31, 2028**
- Multi-purpose dwelling: only the residential portion is eligible for subsidies.
- Grants cover taxes as well as the cost of certain materials and associated labor.

Equipment criteria:

- The adoption of resiliency measures* and the installation of thermostats must be linked to another eligible measure** in order to obtain subsidies.
- The subsidy for thermostats excludes new installations of heat pumps.
- Purchased equipment must meet the eligibility criteria and be on the list of eligible models found on the official program website.
- Energy Star Heat Pump Grants: Not eligible in Quebec.
- Doors and windows: Pleaser keep the Energy Star labels on the glass until the advisor's visit.

- All mechanical and electrical systems, except thermostats, must be installed by a certified professional.
- It is strongly recommended to obtain a proof of practice license of the professional.
- If an attestation applies to your renovations, make sure to get the attestation form (available on the program website), confirming that:
 - The installation of an electrical or mechanical system has been carried out by a trained and licensed professional.
 - A geothermal system was installed in accordance with CSA standards.
 - The heat pump has been sized for your entire home.

Eligibility criteria applicable to MURBs

(Residential Building with Multiple Units)

- Must be an occupying owner
- Full building assessment (all units) Mandatory
- Grants for heat pumps and water heaters not applicable
- Subsidy multiplier: installations of renewable energy systems and resilience measures. Not applicable for thermostats
- Maximum amounts per building and owner are applicable depending on the work

Buildings with multiple owners:

- Each owner must apply for an individual grant.
- Reimbursements for building envelope measures must be claimed by a single owner and cannot be split.

*Resiliency measures: See program details online for definitions of eligible measures **Eligible measure: All types of measures carried out that result in financial assistance from the federal program
